#### **The Current Status of the Tarasoff-related Duties**

Intermediate Level - 3.0 CE

This presentation will focus on the history and current analyses of the Tarasoff-related duties to third parties in high risk clinical situations. The topics will include the ethical and legal implications of duties to third parties; the history and evolution of the Tarasoff duties; and presentations of significant court cases and relevant state statutes. Research findings related to the Tarasoff duties will also be discussed.

### **Session D**

#### **Throwing Yourself In: A Crash Course in Dialectical Behavior Therapy**

Intermediate Level - 6.0 CE

Patrick Kerr, PhD and Martha Fernandez, P

Dialectical Behavior Therapy (DBT) is a cognitive-behavioral treatment with extensive scientific evidence for reducing life-threatening, impulsive and high-risk behaviors in people with multiple psychiatric disorders and complex psychopathology. This workshop will start with an introduction to the scientific evidence for DBT, as well as the theoretical and philosophical foundations of the treatment. Using a combination of didactic, demonstration, and experiential methods, the workshop will then provide participants with an understanding of all the required components of comprehensive DBT, including: treatment techniques and strategies used in individual DBT; DBT skills coaching steps and strategies; DBT skills training, including the skills taught; and the functions and purpose of DBT consultation teams. The specific skills taught in DBT will be described and explained, with demonstrations of select skills. Finally, appropriate adaptations of DBT that may be required in certain clinical settings will be discussed.

Participants will be able to:

1. describe research on the efficacy of dialectical behavior therapy;
2. differentiate populations for whom DBT is and is not indicated;
3. apply required components of comprehensive DBT;
4. demonstrate individual therapy techniques and strategies in DBT; and
5. demonstrate skills taught in DBT.

Ms. Neely is a Board Certified Assistant Behavior Analyst and a WV Provisionally Licensed Counselor at WHOLE Families/WHOLE Veterans PLLC, Morgantown. ## Session E

### Mild TBI and Comorbid PTSD

Novice Level - 3.0 CE

Agnieszka Hornich, PhD

The presentation will begin with an overview of mild TBI, underlying mechanisms of injury and associated symptoms, as well as typical treatment course. The challenge of differential diagnosis in cases of co-morbid trauma and stressor-related disorders will be discussed. The presentation will conclude with an overview of treatment planning for cases of mild TBI with co-morbid psychological disorders.

Participants will be able to:

1. list criteria for classification of mild TBI and identify typical symptom presentation/course.
2. identify mechanisms of diffuse axonal injury, associated symptoms, and appropriate behavioral interventions.
3. identify symptom overlap between post-concussive syndrome and PTSD and explain challenges of differential diagnosis.
4. create appropriate treatment plan for individual diagnosed with Mild Neurocognitive Disorder Due to TBI and Comorbid PTSD.

## Session F

### The Early Career Psychologist Supervisor: Clinical and Ethical Considerations Across Professional Settings and Roles

Novice-Intermediate Level - 1.5 CE

Early Career Psychologists (ECPs) are faced with balancing numerous simultaneous demands including training, licensure, professional identity development, career planning, and work-life balance. Many ECPs take on additional responsibility when supervising and teaching students and trainees as clinical assistant or full faculty. This panel presentation will provide an overview of issues facing ECP supervisors, introduce recommendations for successful self-management in numerous simultaneous roles, and will provide best practice guidelines for supervisors in various settings including rural integrated primary care, academic settings, and specialty psychology (psycho-oncology).

Participants will be able to:

1. identify and discuss the benefits and challenges of supervising as an ECP.
2. share tips for balancing supervision demands while maintaining focus on one's own professional development and training needs.
3. provide best practice recommendations for supervising students/interns/trainees in various settings.
4. share specific resources that may promote the development of specialized supervision competency in various professional settings.

The West Virginia Psychological Association (WVPA) is fully committed to conducting all activities in strict conformance with the American Psychological Association's Ethical Principles of Psychologists.

When a participant, either orally or in written format, files a grievance and expects action on the complaint, the following actions will be taken.

1. If the grievance concerns a speaker, the content presented by the speaker, or the style of presentation, the individual filing the grievance will be asked to put his/her comments in written format. The CE Chair will then pass on the comments to the speaker, assuring the confidentiality of the grieved individual.
2. If the grievance concerns a workshop offering, its content, level of presentation, or the facilities in which the workshop was offered, the convention chair will mediate and will be the final arbitrator. If the participant requests action, the convention chair will:
  - a. attempt to move the participant to another workshop or
  - b. provide a credit for a subsequent year's workshop or
  - c. provide a partial or full refund of the workshop fee.

Actions 2b and 2c will require a written note, documenting the grievance, for record keeping purposes. The note need not be signed by the grieved individual.

3. If the grievance concerns a WVPA CE program, in a specific regard, the CE Chair will attempt to arbitrate.

## Session G

### Risk and Rehabilitation in the Criminal Justice System

Novice Level - 1.5 CE

This presentation will focus on the leading theories of risk assessment and rehabilitation for individuals who have entered the criminal justice system that can help guide psychologists who are tasked with assessing and treating individuals to reduce recidivism. The role of mental illness and trauma in understanding risk assessments and rehabilitation will be reviewed.

Participants will be able to:

1. explain the current theories of recidivism risk and the associated assessment measures;
2. discuss evidenced based rehabilitative programs that target criminal behavior;
3. critique how mental illness and trauma impact the application of risk and rehabilitation theories in the criminal justice setting; and
4. describe how trauma-informed care can impact rehabilitation for individuals in the criminal justice setting.

## **Session H**

### **Developmental Disabilities, Trauma and PTSD: What's New?**

Novice Level - 1.5 CE

Joseph R. Scotti, PhD, and Claudia S. Neely, MA, MDiv, WV Provisionally Licensed Counselor

The field of trauma psychology has largely not dealt with traumatic events and their fall-out within under-served populations, particularly persons with intellectual and developmental disabilities and autism spectrum disorder. Not only is there little information on the types of trauma that persons with disabilities experience, there is a virtual absence of information on the impact of traumatic events and how to recognize symptoms of traumatic stress and PTSD in this population. The presentation will provide data on a statewide study of persons with disabilities, including events and related outcomes. The presenters will discuss how to recognize the impact of trauma in this population and how to address it. Particular attention will be given to school-age children and addressing their needs.

Participants will be able to:

1. describe the range of traumatic events to which persons with disabilities are exposed;
2. recognize symptoms of traumatic stress and PTSD in persons with disabilities;
3. develop appropriate trauma-focused interventions for persons with disabilities; and
4. specify appropriate trauma-focused interventions for children with disabilities in school settings.
