**Billy Rutherford, Psy.D.** is a clinical psychologist on the Posttraumatic Stress Disorder Clinical team at the Hershel "Woody" Williams VA Medical Center in Huntington, WV where he has served since 2009. Dr. Rutherford's clinical interests include evidence-based therapy interventions for Veterans with PTSD and trauma-related disorders as well as relationship issues in Veterans. He serves as a clinical supervisor and evidence-based therapy mentor for pre-doctoral psychology interns at the Woody Williams VAMC. Dr. Rutherford is a representative-at-large for WVPA and has produced the podcast "Appalachia on the Mind." He earned a Psy.D. in clinical psychology from Marshall University and completed a predoctoral psychology internship at the W.G. "Bill" Hefner VA Medical Center.

### Therapy Interventions for Veterans with Trauma-Related Disorders Across a Spectrum of Clinical Presentations.

An overview of PTSD and trauma-related disorders in Veteran populations will be presented along with discussion of common co-morbidities such as depression, substance use disorders, and suicidality. The roles of natural recovery and obstacles to recovery in treatment will be reviewed. Elements of various evidence-based and trauma-informed approaches will be presented along with a spectrum of case complexity to include those with dissociation and/or more complex trauma history.

#### Learning Objectives:

(a) Participants will identify common symptoms of PTSD, trauma-related disorders, and common co-morbidities that may present in the Veteran population.

(b) Participants will identify common risk factors for suicide and resources associated with safety planning in the Veteran population.

(c )Participants will conceptualize development of trauma-related disorders from the perspective of a failure of natural recovery processes.

(d) Participants will identify trauma-informed principles for addressing clinical issues of Veterans along a continuum of case complexity. James L. Werth, Jr., PhD, ABPP, received his PhD in Counseling Psychology from Auburn University in 1995 and his Master of Legal Studies degree from the University of Nebraska – Lincoln in 1999. He currently serves as the Behavioral Health and Wellness Services Director as well as the Black Lung Program Director for Stone Mountain Health Services, a Federally Qualified Health Center with 11 medical and 2 respiratory care clinics spread across 7 counties in Southwest Virginia. In addition, he serves as Chair of Stone Mountain's Patient Safety / Risk Management / Performance Improvement Committee, coordinates the annual reports and grant submissions, and is active in community outreach and collaboration.

He is a Licensed Clinical Psychologist in Virginia, is board certified in Counseling Psychology (American Board of Professional Psychology), and is a Fellow of the American Psychological Association. He also serves as the Coordinator of the American Psychological Association (APA) accredited Southwest Virginia Psychology Doctoral Internship Consortium, of which Stone Mountain is a part. He has been a member of the Virginia Board of Psychology since late 2014 and currently serves as Vice Chair of the Board and Chair of the Regulatory Committee. He is the Clinical Representative on the Board of Directors for the Virginia Community Healthcare Association, Chair of the Credentialing Committee for the Community Care Network of Virginia (CCNV), and is a member of the CCNV Medical Management Committee. He received the American Psychological Association's 2016 "Excellence in Rural Psychology Award" as well as the 2016 Virginia Association for Rural Health's "Charles Crowder, Jr. Award" in recognition of "outstanding individual commitment and service to the advancement of rural health in Virginia." He accepted both on behalf of the Stone Mountain Behavioral Health Team.

Prior to coming to Stone Mountain, he was the founding Director of the Radford University Doctor of Psychology (Psy.D.) Program, which had emphases on rural mental health, cultural diversity, social justice, and evidence-based practice. The Psy.D. was the first doctoral program on campus. It was accredited by the American Psychological Association in the shortest time possible, allowing even the first cohort of students to say they graduated from an accredited program. # Responding to Common Ethical Issues in Small Communities and Rural Areas

Small / rural communities may be marginalized. This presentation highlights the ethical dilemmas that frequently occur in such settings, such as competence, confidentiality, and multiple relationships. This workshop includes examples of dilemmas and potential solutions that can be implemented proactively or immediately when recognition of a problem occurs.

## **Grievance Procedures**

The West Virginia Psychological Association (WVPA) is fully committed to conducting all activities in strict conformance with the American Psychological Association's Ethical Principles of Psychologists.

When a participant, either orally or in written format, files a grievance and expects action on the complaint, the following actions will be taken.

- 1. If the grievance concerns a speaker, the content presented by the speaker, or the style of presentation, the individual filing the grievance will be asked to put his/ her comments in written format. The CE Chair will then pass on the comments to the speaker, assuring the confidentiality of the grieved individual.
- 2. If the grievance concerns a workshop offering, its content, level of presentation, or the facilities in which the workshop was offered, the convention chair will mediate and will be the final arbitrator. If the participant requests action, the convention chair will:
  - a. attempt to move the participant to another workshop or
  - b. provide a credit for a subsequent year's workshop
  - or

c. provide a partial or full refund of the work shop fee.

Actions 2b and 2c will require a written note, documenting the grievance, for record keeping purposes. The note need not be signed by the grieved individual.

3. If the grievance concerns a WVPA CE program, in a specific regard, the CE Chair will attempt to arbitrate.
